Prerequisites: MATH 2400 (Calculus III) and MATH 3130 (Linear Algebra) or the equivalent. Some experience writing proofs (such as MATH 2001) would be helpful, but is not required.

Text: J. Oprea, *Differential Geometry and Its Applications*, 2nd ed. (The Mathematical Association of America) 2007.

Course outline: This course will cover the classical theory of curves and surfaces in \mathbb{R}^3 . Topics will include:

- Curves: Frenet analysis of curves in \mathbb{R}^3 , including curvature, torsion, and their interpretations.
- Surfaces: smooth surfaces, tangent vectors, surface area, the Gauss mapping, Gauss and principal curvatures, mean curvature and minimal surfaces, isometric surfaces, geodesics, Gauss's Theorem Egregium and the Gauss-Bonnet theorem.

This material is covered in Chapters 1-6 of the text.

Grading: There will be a midterm and a final exam, both take-home, open book. Each exam will count for 25% of the final grade, and homework will account for the remaining 50%.

Homework: Homework assignments will be due approximately weekly. These assignments will consist mostly of problems from the text, as well as some occasional assignments involving the use of the computer algebra system Maple. You may obtain access to Maple in one of the following ways:

- Maple 16 is installed on the computers in the lab in MATH 217. The lab is open from 8:00 A.M.

- I will send out an email with a discount code which will allow you to purchase your own copy of Maple 16 for \$74.25 online at http://webstore.maplesoft.com. This is 25% off the usual student price of \$99, which in turn is about 1/20 of the regular (non-academic) price and 1/10 of the non-student academic price, so it's a VERY good deal, and I highly recommend it!

You are encouraged to work together on homework, although each student must submit an individual writeup. LATE HOMEWORK WILL NOT BE ACCEPTED.
